Subject: Addendum to Circular No. BAI/CC/BAJC/2026/138 – Indian Team Coaching Camp & Selection for the Badminton Asia U17 & U15 Junior Championships 2026

Dear Sir/Madam,

This is in continuation of Circular No. **BAI/CC/BAJC/2026/138** dated **06th August 2026** regarding the Indian Team Coaching Camp for the **Badminton Asia U17 & U15 Junior Championships 2026**.

As per the **Badminton Asia U17 & U15 Junior Championships 2026 Prospectus**, players are not permitted to participate in the same event across different age categories.

Accordingly, **Ms. Anvi Rathore (BAI ID: 41531)**, who had qualified in both the Girls' Singles U15 and Girls' Singles U17 categories, has opted to participate in the Girls' Singles U15 event. Consequently, the vacancy created in the Girls' Singles U17 event has been filled by **Ms. Akshita Guliya (BAI ID: 41959)**, who is the next eligible player based on the Girls' Singles Selection Trials held at the Centre for Badminton Excellence (formerly PPBA).

The Coaching Camp for the training and preparation of the Indian Sub Junior Team, which will participate in the **Badminton Asia U17 & U15 Junior Championships 2026**, scheduled to be held at **Chengdu, China, from 8th to 13th September 2026**, will be conducted at the **National Center of Excellence (NCE), Guwahati, from 30th August to 5th September 2026**.

All the selected players (as per the revised list enclosed) are **mandatorily required** to attend the coaching camp and report to **NCE, Guwahati** on **29th August 2026 (afternoon onwards)**.

Athletes are required to make their own travel arrangements to reach the National Camp at NCE, Guwahati. You are requested to kindly inform the selected players from your respective State/Unit accordingly.

All other contents of Circular No. **BAI/CC/BAJC/2026/138** shall remain unchanged.
