## **OLYMPIC QUALIFICATION PROCESS FOR PARIS 2024**

As per the Badminton World Federation's (BWF) qualification regulations for Paris 2024 approved by the International Olympic Committee (IOC), the qualification process which started on **1 May 2023** and will run until **28 April 2024** with the **Race to Paris** ranking lists as of **30 April 2024** used to determine the initial list of qualifiers.

### **Singles-**

In each singles discipline, an NOC (National Olympic Committee) has a maximum of two quota places if the players are ranked within the top 16 of the Race to Paris ranking on the qualification date.

### **Doubles-**

In each doubles discipline, an NOC has a maximum of two quota places if both pairs are ranked within the top 8 of the Race to Paris ranking on the qualification date.

## **BAI Selection Guidelines for the Paris 2024**

### **Singles-**

The BAI will consider two singles players in each singles discipline if the players are ranked within the top 16 of the Race to Paris ranking on the qualification date. In case there are more than two players in the top 16 of the Race to Paris ranking on the qualification date, **ONLY** two highest ranking players will be considered for the selection in the Indian team.

### **Doubles-**

The BAI will consider two pairs in each doubles discipline if the pairs are ranked within the top 8 of the Race to Paris ranking on the qualification date. In case there are more than two pairs in the top 8 of the Race to Paris ranking on the qualification date, **ONLY** two highest ranking pairs will be considered for the selection in the Indian team.

### B.4. Type of allocation of quota places:

Quota places are allocated to the athlete(s) by name.

If an NOC has more athletes/pairs qualified in any event than its entitled number of quota places, according to the Race to 'Paris Ranking Lists' as of 30 April 2024, the NOC can decide to decline a quota place allocated to the highest ranked athlete/pair and choose a lower ranked eligible athlete/pair during the different phases of reallocation of quota places, as detailed in paragraph **F. Reallocation of Unused Quota Places**. The NOC will however not be able to enter a declined athlete/pair at the time of final entries, should the lower ranked athlete/pair become unavailable.

## C. ATHLETE ELIGIBILITY

### C.1. Compliance with the Olympic Charter and other relevant rules

All athletes must respect and comply with the provisions of the Olympic Charter currently in force, including but not limited to Rule 41 (Nationality of Competitors) and Rule 43 (World Anti-Doping Code and the Olympic Movement Code on the Prevention of Manipulation of Competitions).

Only those athletes who respect and comply with the Olympic Charter, the World Anti-Doping Code and the Olympic Movement Code on the Prevention of the Manipulation of Competitions, including the conditions of participation established by the IOC, plus the rules of Badminton World Federation, may participate in the Olympic Games Paris 2024.

### C.2. Additional IF eligibility criteria

Athletes must also comply with the following criteria:

- All athletes must have played in a minimum of three (3) tournaments in their respective event counting towards the World Ranking List during the Olympic qualifying period - 1 May 2023 – 28 April 2024. This is also applicable for the Universality places and the Continental Representation places but it is not applicable for the host country places.
- Be ranked on the 'Race to Paris Ranking Lists' as of 30 April 2024. This is not applicable for the host country places.



## D. QUALIFICATION PATHWAY

### D.1. QUOTA PLACES

#### Men/Women/Mixed

The 'Race to Paris Ranking Lists' of 30 April 2024 will be used to allocate the athletes quota places in Men's and Women's Singles, and Men's, Women's and Mixed Doubles. Each list will be based on results achieved during the period 1 May 2023 to 28 April 2024. Participation in any of the following events will count towards the respective 'Race to Paris Ranking Lists' during the qualification period:

- Thomas & Uber Cup
- Sudirman Cup
- World Championships
- Grade 2 BWF tour tournaments – Levels 1 to 6
- Grade 3 BWF Continental tour tournaments - International Challenge, International Series & Future Series
- Continental Championships (individual and team)
- Continental Multi sports games – Pan American Games, European Games, and African Games (if sanctioned during the qualification period).
- Any other international event sanctioned by BWF and included in advance and with BWF approval as being part of the World Ranking Lists

BWF will allocate quota places satisfying the following principles:

- Allocation of quota places (see section **D.1. Quota Places** for Singles and Doubles).
- Allocation of host country places in singles from World Ranking Lists or as notified from the host country by 8 May 2024 (see section **D.2. Host Country Places**)
- Allocation of Universality Places in singles (see section **D.3. Universality Places**)
- Allocation of Continental Confederation Places (see section **D.1. Quota Places** for Singles and Doubles).

	<p>In each singles event, there shall be at least two (2) athletes from each of the five (5) BWF Continental Confederations (Continental Representation Places) provided the player is ranked 250 or above (ranked between 1-250) in the BWF Race to Paris Ranking list of 30 April 2024. If for a particular Continental Confederation there is no singles athlete qualified in an event, the athlete selected for Continental Representation Place shall be the highest ranked athlete in the BWF 'Race to Paris Ranking List' of 30 April 2024 from the respective continent. An athlete receiving a Universality place shall not be considered as the athlete satisfying the minimum continental representation in a specific Singles event.</p> <p>An athlete receiving a host country place shall not be considered as satisfying the minimum continental representation in a specific Singles event.</p> <p>Considering qualification in all events, no NOC can qualify athletes/pairs in more than two (2) events through the Continental Representation Place system. If an NOC has athletes/pairs eligible in more than two (2) events, then the NOC must choose which athletes/pairs are qualified and the athlete/pair the quota place that has been declined will be offered to the next eligible athlete/pair. The NOC's choice will be considered as final.</p> <p>If an athlete qualifies (and is selected) in more than one (1) event, then the resulting unused athlete quota place will be allocated to the next highest ranked eligible athlete of the same gender in the singles event on the BWF 'Race to Paris Ranking Lists' of 30 April 2024. The offer of this quota place will however be conditional on the athlete who is qualified in more than one (1) event being confirmed and entered by his/her NOC in the Olympic Games Paris 2024.</p>

The 48 pairs quota places will include the allocation of Continental Representation Places.</p> <p>In each doubles event there shall be at least one (1) pair from each of the five (5) BWF Continental Confederations (Continental Representation Place), which shall be the highest ranked pair in the 'Race to Paris Ranking Lists' of 30 April 2024 from the respective Continent, provided the pair is ranked 50 or above (ranked between 1-50) in the BWF 'Race to Paris Ranking Lists' of 30 April 2024.</p> <p>Considering qualification in all events, no NOC can qualify athletes/pairs in more than two events through the Continental Representation Place system. ## D.2. HOST COUNTRY PLACES

The host country will be allocated one (1) quota place, in the men's singles event and one (1) quota place in the women's singles event, should the host country not have already qualified a quota place in the singles events, in either gender, from the BWF 'Race to Paris Ranking List'.

Qualification of a doubles pair(s) through the 'Race to Paris Ranking Lists' of 30 April 2024, as per the process described under section **D.1. Quota Places** shall not prevent the host country from using the two (2) host country quota places in the singles events.

The athletes receiving host country places will be the highest ranked athlete(s) on the respective singles 'Race to Paris Ranking Lists' as of 30 April 2024. If there is no host country athlete on the 'Race to Paris Ranking Lists', in the singles event(s), the host country will choose and confirm the respective athlete(s) to the BWF, at the latest by 8 May 2024.

## D.3. UNIVERSALITY PLACES

Four (4) Universality places are made available to eligible NOCs at the Olympic Games Paris 2024: two (2) in the men's singles and two (2) in the women's singles.

On 1 October 2023, the International Olympic Committee (IOC) will invite all eligible NOCs to submit their requests for Universality places. The deadline for NOCs to submit their requests is 15 January 2024. The Tripartite Commission will confirm, in writing, the allocation of Universality places to the relevant NOCs after the end of the qualification period for the sport concerned.

Detailed information on Universality places is contained in the "Games of the XXXIII Olympiad, Paris 2024 - Olympic Games Universality Places - Allocation Procedure and Regulations" document.

## E. CONFIRMATION PROCESS FOR QUOTA PLACES

### E.1. CONFIRMATION OF QUOTA PLACES

The list of initially qualified athletes/pairs for each event (including Continental Representation Places, host country places and Universality places) will be published as part of the 'Race to Paris Ranking Lists'



of 30 April 2024 at ([www.bwfbadminton.org](http://www.bwfbadminton.org)). BWF will inform the respective NOCs/National Federations of their allocated quota places by no later than 10 May 2024

NOCs will then have two (2) weeks, until 24 May 2024 to confirm that they will use the quota places, as detailed in section **G. Qualification Timeline**.

## E.2. CONFIRMATION OF HOST COUNTRY PLACES

The host country must confirm in writing to the BWF by 8 May 2024 the use of its host country places.

## F. REALLOCATION OF UNUSED QUOTA PLACES

### F.1. REALLOCATION OF UNUSED QUOTA PLACES

If an allocated quota place (except for those pertaining to Continental Representation Places) is not confirmed by the NOC by the confirmation of quota place deadline (24 May 2024) or is declined by the NOC, the quota place will be reallocated to the next highest ranked eligible athlete/pair according to the 'Race to Paris Ranking Lists' of 30 April 2024, who has not yet qualified for the Olympic Games. This process will be repeated in different phases until the quota places have been filled for each event and gender and the confirmation deadlines for the reallocation phases will be decided by BWF at its sole discretion.

If an NOC declines an athlete/pair's quota place in the first allocation phase, and then accepts a quota place for a lower ranked eligible athlete/pair in the reallocation phase, it will not be possible to enter the first athlete/pair at the time of final entries, should the lower ranked athlete/pair become unavailable.

Reallocation of quota places, due to an athlete being qualified in more than one event, will be offered on a conditional basis, should the athlete qualified in more than one event, no longer be available.

If an allocated quota place for the purpose of Continental Representation Places is not confirmed by the NOC by the confirmation of quota place deadline (24 May 2024) or is declined by the NOC, the quota place will be reallocated to the next highest ranked eligible athlete/pair according to the 'Race to Paris Ranking Lists' of 30 April 2024, who has not yet qualified for the Olympic Games, from that same Continental Confederation.

This process will be repeated until the quota places have been filled for each respective Continental Confederation in the respective event/gender. If no athlete/pair is eligible for the Continental Confederation Places, then the quota place will be allocated to the next highest ranked eligible athlete/pair according to the 'Race to Paris Ranking Lists' of 30 April 2024.



## F.2. REALLOCATION OF UNUSED HOST COUNTRY PLACES

If the host NOC does not confirm the host country place(s) by the deadline 8 May 2024, then such unused host country place(s) will be reallocated to the next highest ranked eligible athlete according to the 'Race to Paris Ranking Lists' of 30 April 2024, who has not yet qualified for the Olympic Games. The process will be repeated until the quota has been filled for each gender.

## F.3. REALLOCATION OF UNUSED UNIVERSALITY PLACES

Any unused Universality place(s) will be reallocated to the next highest-ranked eligible athlete of the same gender according to the 'Race to Paris Ranking Lists' of 30 April 2024.
