## **REVISED CIRCULAR FOR AADHAR HISTORY VERIFICATION DURING JR. AGE GROUP TOURNAMENTS**

Dear All,

With reference to our earlier circular No. BAI/GEN/AADHAR/157/2024 dated September 28<sup>th</sup>, 2024, regarding the verification of Aadhar history during BAI/State Junior Age Group Tournaments, we would like to inform you of a significant update.

Badminton Association of India (BAI) will not consider Aadhar Card as the only valid proof of age. In light of this decision, the Badminton Association of India (BAI) has revised the use of Aadhar history Verification during tournaments.

If any protest comes during Junior Age Group Tournaments, and discrepancies are found in Aadhar history verification the players will not be immediately disqualified or excluded. Instead, the following procedure will be followed:

1. Players will be required to submit their consent/affidavit confirming that their date of birth is accurate. Additionally, they must agree to cooperate with any subsequent investigation that BAI may conduct.
2. If any minor players (below 18 Yrs), the **consent of parents/guardians** will be required for accepting responsibility for the information provided.
3. Players must provide documents as per the BAI Standard Operating Procedures (SOP) to support their age verification.

4. If necessary, BAI will conduct a medical examination of the players to confirm their age eligibility.
5. If any player fails to provide the Aadhaar OTP for Aadhar history verification, they must submit an affidavit confirming the accuracy of their details. Failure to submit the affidavit will result in the player being ineligible to participate in the future BAI/State tournaments and will not receive any certificates until the investigation is completed.

This revised circular ensures a fair and transparent process, for verification with the opportunity for players to participate in the tournaments.
