1. Confirmation of the Minutes of the last Annual General Meeting held virtually on 30<sup>th</sup> January 2021
2. Adoption of the Annual Report for the year 2020-21.
3. Consider and approve the Audited accounts and financial statements of the Association for the Financial Year 2020-21.
4. Appointment of Auditor for the financial year 2021-2022 & 2022-2023.
5. To confirm the yearly calendar of BAI for the year 2022-23.

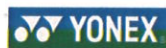
