Mr. Devender Singh suggested that if any unit after opting to host and getting allotted any tournament fails to conduct the same, a fine should be imposed on them. Mr. S. A. Rawal proposed that the said penalty should be Rs. 50,000/-. The House unanimously approved the said proposal and it was also decided that in case the penalized unit does not pay the fine then it shall not be allotted any tournament in the future till it pays the penalty.

Confirmation of yearly calendar of the BAI for the Year 2014-2015

The Calendar of Badminton Association of India for the year 2014-2015 as proposed was confirmed and approved.

Agenda No. 7

The Election of the Office Bearers and Members of Executive Committee, BAI for the tenure of next four years (2014-2018) commencing from 13.06.2014.

At 1:00 pm, which was the time stipulated by the Hon'ble Returning Officer for the conduct of the election of the Office Bearers and Members of Executive Committee, BAI for the tenure of next 4 years (2014 to 2018) commencing from 13th June 2014, the related Agenda No. 7 was taken up. The Hony. Gen. Secretary, BAI with the permission of the Chair requested all the Office Bearers of BAI, who were present on the dais to kindly leave the dais. Thereafter the Hony. Gen. Secretary with the permission of the Chair requested the independent Returning Officer - Hon'ble Mr. Justice A. N. Gupta, a retired High Court Judge and Mr. S. K. Bhatt (Retd. District Judge), Assistant Returning Officer to come to the dais and take the charge. The Hony. Gen. Secretary also requested Mrs. Rachna Govil, Regional

Director, SAI Regional Centre, Lucknow, who was nominated as the Observer of the Government of India and Mr. Anandeshwar Pandey, Joint Secretary, Indian Olympic Association, who was nominated as the Observer by the IOA, to take their respective seats on the dais.

The Returning Officer apprised the House that since for almost all the posts of Office Bearers there was Uncontested Returns i.e. the number of contesting candidate(s) for any post, after the last hour fixed for withdrawal of candidatures was over, was equal to the number of seats to be filled, the respective candidates were duly elected unopposed to the posts for which they had filed their nominations as Office Bearers and Members of the Executive Committee of BAI.


However, for the one post of Secretary – Coaching & Development, BAI there were two contesting candidates – Mr. K. N. Jaiswal and Mr. Omar Rashid. Although Mr. Omar Rashid announced his retirement from the election for the said post at the beginning only but since there was no provision regarding retirement in the process of these elections, the Returning Officer decided to take polls and the polling was done for this post only.

Before opening the polls, the ballot box was opened and shown to all the delegates present in the AGM. Thereafter the ballot box was locked and sealed by the Returning Officer and was kept in the centre of the hall. The Returning Officer said that the polling shall be done only in accordance with the List of Electoral College and those delegates, whose names were not in the list of Electoral College would not be allowed to vote. Thereafter, the names of the delegates were called as per the Electoral College List and they casted their votes by using secret ballot. The Returning Officer, after the expiry of the scheduled time of polls, commenced the counting of votes. Upon counting it was found that out of total number of 47 votes casted Mr. K. N. Jaiswal received 43 votes, Mr. Omar Rashid received 2 votes and 2 votes were declared invalid. Accordingly, the Returning Officer declared Mr. K. N. Jaiswal elected to the said post.



Thereafter, the Returning Officer declared the complete result of the Elections of the Office Bearers and Members of Executive Committee, BAI – 2014 in the AGM in the presence of all the delegates and the Observers, which is as follows:-

The Declaration of Result (Form - 15) after being duly signed by the Returning Officer, Assistant Returning Officer, Observer from the Government of India and the Observer from the IOA was handed over to the President, BAI by the Returning Officer.

The Returning Officer after declaring the results also gave the Certificate of Election to the newly elected Office Bearers and Members, Executive Committee, BAI, which were also signed by the Assistant Returning Officer, the Government of India Observer and by the IOA Observer. Thereafter, the Returning Officer in his address to the House said that it is really pleasant that everybody in BAI has extended his / her full support to him in conducting the aforesaid elections in a transparent and peaceful manner. He further added that the BAI is shaping well into an organization, where everybody has the opportunity to work and contribute towards the development and upliftment of this sport.

The Observer from Government of India, while addressing the House praised the Hon'ble Returning Officer and his team as well as the BAI for getting conducted the pre-poll and the polling process for the said elections in a perfect, independent and impartial manner and in accordance with the process, procedure and schedule as prescribed in the Model Election Guidelines issued by the MYA&S as contained in the National Sports Development Code of India – 2011. The IOA Observer in his address particularly praised the Returning Officer and the BAI for introducing the system of voting by secret ballot in such a wonderful manner.

Thereafter the President, BAI expressed his gratitude towards the Hon'ble Returning Officer, the Assistant Returning Officer and the Observer from the Government of India and Indian Olympic Association for sparing their valuable time and extending their full support to BAI in its endeavour to conduct the aforesaid elections in a fair, transparent, democratic and peaceful manner.

Any other matter with the permission of the Chair

The following matters were raised for the permission of the Chair:-

- a. The Hony. Gen. Secretary, sought permission from the Chair to submit the proposal regarding the creation of "Players Benefit Fund" for benefit of former badminton players.
- b. The Hony. Gen. Secretary sought permission to lay before the House all those matters in which decisions were taken by the President, BAI in the interregnum period, for approval and confirmation by the House.
- c. Mr. K. N. Jaiswal, sought permission from the Chair to submit a proposal regarding the formation of different Sub-Committees of BAI.
 - The President, BAI permitted to take up all the aforesaid matters and they were taken up for discussions one-by-one.
 - a. Dr. Vijai Sinha, Hony. Gen. Secretary apprised the House that the President, BAI has set up a special BAI fund of Rs. 25 Lacs for the benefit of former badminton players, who have played at the national and / or international level and are in need of financial assistance. The full House appreciated this proposal with round of applauds. Mr. Pradeep S. Gandhe said that this is one of the first-of-its-own-kind concrete steps taken by the BAI under the dynamic leadership of Dr. Akhilesh Das Gupta, President, BAI. The President, BAI stated that an amount of Rs. 25 Lacs would be allocated to this fund every year. He further clarified that even if the complete amount is not utilized in that very year, it shall not lapse and the amount remain to be utilized would be carry forwarded and added to the next years' fund. The said proposal was unanimously accepted and approved by the House.
 - b. The Hony. Gen. Secretary reported to the House about all the decisions that were taken by the President, BAI in the interregnum period i.e. after the last EOGM of BAI



- at Mumbai on 31.08.2013 and all those decisions were approved and confirmed by the full House.
- c. Mr. K. N. Jaiswal proposed that looking to the tremendous growth of BAI in the last 2 ½ years, the President Dr. Akhilesh Das Gupta may be authorized to appoint and constitute a fresh all the Sub-Committees of BAI. The President may be further authorized to create new Sub-Committee(s), if required, and also appoint its Chairman and Members. Mr. Devender Singh seconded this proposal. The House unanimously approved this proposal and authorized the President, BAI to appoint and constitute Sub-Committees of BAI, as deemed necessary.
